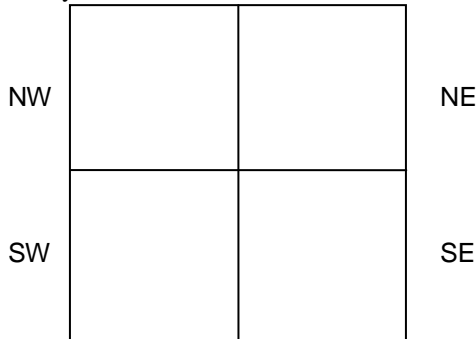

- Projects applied for must be within the WSRCD; and
- Failure of a landowner to meet Landowner Responsibilities may negate him / her from other WSRCD programs.

Landowner Responsibility:

- Provide access to project for installation, maintenance, removal, and tours;
- Indemnify and save harmless the District from any and all actions, claims, suits, damages, injuries, or other loss no matter howsoever arising as a result of the construction, operation or maintenance of the project.
- Grant the conservation district the right to use any information related to this project for educational or promotional purposes.

Conservation District Responsibility:

- Determine application priorities in consultation with the Sub-District & Board members.
- At the request of the applicant, pending availability of systems, WSRCD staff will deliver and will install the watering systems described below.
- Watering systems will be provided for a minimum of 3 weeks with the possibility of a 2 week extension dependant upon program demand.
- Notify the applicant of the removal date of the system upon delivery.
- Maintain and remove the system.
- Provide technical and on-site assistance; and
- Retain the option to use photos taken of the project for public relations purposes.
